CALIFORNIA CIVIL CODE 1834.5

Abandoned Animals Notwithstanding any other provision of law, whenever any animal is delivered to any veterinarian, dog kennel, cat kennel, pet grooming parlor, animal hospital or any other animal care facility pursuant to any written or oral agreement entered into after the effective date of these section, and the owner of such animal does not pick up the animal within 14 calendar days after the animal was due to be picked up, the animal shall be deemed to be abandoned. The person into whose custody the animal was placed for care shall first try for a period of not less than 10 days to find a new owner for the animal, and if unable to place the animal with a new owner, shall thereafter humanely destroy the animal so abandoned.

1. Owner agrees to pay for any and all property damages that their dog(s) may destroy while at The Indigo Dog House. Owner also understands that their dog(s) may be 'crated' in the event of property destruction for the prevention of further damages.
2. By signing this contract and leaving their dog with The Indigo Dog House, Owner certifies to the accuracy of all information given about said dog(s). In addition, Owner certifies that they have read and understand all accompanying paperwork provided by The Indigo Dog House.
3. The Indigo Dog House shall exercise due diligence and reasonable care for the dog(s) delivered by the owner to The Indigo Dog House for boarding services. All dogs are handled or cared for by The Indigo Dog House staff without liability on The Indigo Dog House's part for loss or damage from disease, theft, fire, death, escape, injury or harm from any other unavoidable causes, due diligence and care having been exercised. The Owner of the dog(s) further agrees to be solely responsible and liable for any and all acts or behavior of said dog(s) while their dog(s) is in the care of The Indigo Dog House.
4. The Indigo Dog House reserves the right to refuse any dog.
5. Owner agrees to pay any reasonable attorney fees incurred by The Indigo Dog House to collect any charges incurred by the owner.
6. Owner specifically represents to The Indigo Dog House that the dog(s) has not been exposed to rabies, bordetella, or other communicable diseases within any thirty day period prior to boarding, and that all vaccinations are current. Dogs arriving with fleas or ticks will be bathed at the owner's expense.
7. All charges incurred by Owner shall be payable when billed by The Indigo Dog House. In the event of a check returned for insufficient funds, the client agrees to pay all charges incurred by The Indigo Dog House to collect this debt plus an additional \$25.00. Client may then be placed on a cash only account basis based on management's decision.

8. If the dog(s), becomes ill or if the state of the dog's health otherwise requires professional attention, The Indigo Dog House, in its sole discretion, may engage the services of a veterinarian, administer medicine or give other requisite attention to the animal, and the expense thereof shall

be paid by the Owner.

9. Owner agrees that their dog(s) maybe videotaped, photographed and recorded while they are receiving services from The Indigo Dog House. The Indigo Dog House shall be the exclusive owner to the results and all proceeds of such tapings, photography, and recordings with the rights, throughout the world, an unlimited number of times in perpetuity, to copyright, to use and to license to others in any manner. The owner further agrees that their dog(s) may be used in any and all media and in the promotion, advertising, sale and publicizing, and exploitation of The Indigo Dog House at no cost to The Indigo Dog House.

10. Kennel Cough can be contracted any time your dog comes into contact with another dog. You may want your dog to receive a bordetella shot prior to boarding with us, but the bordetella vaccine is like the human flu shot and does not immunize all dogs against all strains of kennel cough. The Indigo Dog House and its staff will in no way be held liable for any strain of kennel cough that my dog may contract while at The Indigo Dog House.

11. If Owner is unable to pick up dog(s) for any reason, owner agrees to contact The Indigo Dog House immediately and agrees to pay any and all additional fees incurred.

All dogs are accepted for boarding in accordance with California Civil Code Section 1834.5, which states that 14 days after the designated pickup date, a dog is considered abandoned if no other alternative pickup arrangements have been made. The Indigo Dog House will report any abandoned animal immediately and take appropriate action if not contacted by the owner within the allowed time frame.

12. The Owner releases The Indigo Dog House, its owners, and employees, from all risks and damages, which may occur when Indigodog services are provided to their dog(s).

13. If your dog injures another dog and/or person while at The Indigo Dog House, you are responsible for any and all damages, including the injured party (s) veterinary and/or medical bills.

14. The provisions in this agreement apply to any future time the owner receives services for the same or other dog(s) at The Indigo Dog House. This agreement will be signed only once.
